In the event an emergency meeting is needed, notice may be posted less than 48 hours in advance in accordance with state statute. Per state statute, media who have made their written request to the City Clerk will be notified when meetings are scheduled.

### **2012 SCHEDULE OF COMMITTEE MEETINGS**

All meetings are held in the City Council Chambers in the Troy Municipal Building unless otherwise stated. All Special Committee meetings will be posted no less than 48 hours in advance on the official bulletin board by the City Clerk's office in the Troy Municipal Building located at 116 E. Market as they are scheduled. In the event an emergency meeting is needed, notice may be posted less than 48 hours in advance in accordance with state statute. All City Council Steering Committee meetings and Special Committee meetings are announced and posted on an as scheduled basis. Per state statute, any of the media who have made their written request to the City Clerk will be notified when meetings are scheduled.

**Economic Development Commission/EDR:** Meetings are usually held in the training room at the Troy Municipal Building. The Committee meets on an as needed basis.

**Planning Commission:** Meetings are held on the second Thursday of each month at 7:30 p.m. Planning & Zoning Committee meetings and Subdivision Committee meetings are scheduled as needed at 7:00 p.m. before the regular Planning Commission meeting.

**Rezoning Hearings:** Public hearings are scheduled on an as needed basis at 7:00 p.m. prior to the regular meeting. Public hearing notices are published in the legal section of the Times Tribune 15 days but not more than 30 days prior to the public hearing.

**Troy Historic Preservation Commission:** Meetings are held quarterly on the fourth Monday of January, April, July, and October at 7:30 p.m.

**Board of Appeals:** The Board of Appeals does not conduct regularly scheduled meetings. Public hearings and special meetings are scheduled on an as needed basis. Public hearing notices are published in the legal section of the Times Tribune 15 days but not more than 30 days prior to the public hearing.

**Board of Fire and Police Commissioners:** Meetings are held in the Council Chambers unless otherwise posted at 9:00 a.m. on the third Thursday of every other month. Meetings are held in January, March, May, July, September, and November.

**Trustees Police Pension Fund Board:** Meetings are held in the Council Chambers unless otherwise posted quarterly at 5:00 p.m. on the second Wednesday of January, April, July, and October.
